#### Local 195 Members and Leaders Join Other Unions in Rally for Your Health Insurance

On September 13, a loud and proud contingency from Local 195 joined our sisters and brothers from across the Garden State to show labor's united opposition to recent proposals that would drastically shift the cost of health insurance to the state's public sector workers

"If New Jersey's health insurance program needs to balance its books, it must not do so on the backs of the hard-working women and men in the public sector workforce," said Local 195 Business Representative Gerald Newsome. "These benefits are that our members have earned, and we're not going to stand idly by while some misguided penny pinchers try to take them away."

Matt Biggs, International President of IFPTE, noted that this budget-cutting tactic isn't unique to New Jersey. "All too often, those in power look to weaken the benefits our members have earned in order to cut costs, whether it be raiding our pensions or attacking our healthcare plans," Biggs said. "The right way to deficient remedv any funding is by making our tax system more progressive, not by increasing the burden on our working families."

The proposed change would raise premiums by about 20% for New Jersey's public sector workers. If passed, it would impact more than 800,000 workers at the local, county and state levels.

UPDATE: On Wednesday, September 14, the New Jersev State Health Benefits Commission voted to institute the 20% increase in employee premiums for its program participants. Working with a coalition of state employee unions, Local 195 was able to draft a tentative agreement with the state that would significantly reduce the increase for state employees to as little as 3%. Local 195 will continue to fight for ways to lessen the onerous impact of this ill-conceived move on the 800.000 state, county and municipal employees who participate in the program.
