

### THE FUTURE OF YOUR **PENSION IS AT STAKE**

The Election process for PERS Trustee has begun as of April 1, 2015. Local 195, IFPTE and the NJ State AFL-CIO has endorsed Carey Brown for Election to the Public Employee's Retirement (PERS) Board of Trustees. Carey Brown is a career public worker and CWA Local 1037 shop steward. Ballots were shipped to State employing locations. Only Active State employees can vote in State elections. Retirees cannot vote. Balloting closes May 31, 2015. If you want to vote on line please log onto: https://vote.election-america.com/NJState.

Also, please note an active PERS member will need their ballot instructions from their employer in order to have their "Election Code" number and their "Voting Pin" number.

### KEAN UNIVERSITY LOSING UNIONIZED JOBS

Local 195, IFPTE held a labor protest at Kean University on March 2, 2015. For months Local 195, IFPTE politically lobbied and fought against Kean University President Dawood Farahi who spearheaded the effort to contract out and privatize our senior building maintenance workers and ground workers is a political move just to dismantle organized labor and eliminate public sector unionized jobs.

This administration at Kean University including the Board of Trustees and local politicians have turned a deaf ear to cost savings. Local 195, IFPTE reached out to our International to assist us in this battle. IFPTE conducted research and analyzed the RFP's. Grounds maintenance contract proposals included language on markups for any subcontracted labor ranging from 5% to 15% depending on the contractor, contractors' bids include costs for profit and overhead, materials and supplies. Most bids for grounds maintenance did not include itemized snow removal work, but rather a list of costs billed at premium rates. This is not a cost savings to the tax payers of New Jersey nor Kean University. The proposals do require more workers at lower wages to accomplish the work.

Local 195, IFPTE is not done fighting this battle. People who work at the campus need a living wage. These anti-labor busting RFP's adds to the working poor for what was once a living wage for people turns into part time positions and with zero benefits.

So many questions about this privatization still goes unanswered. Some of these questions are the following:

Why is privatization being proposed? Who benefits? The employees hired by the contractors do not benefit. Wages, sick time and vacation time get drastically cut. The next two questions are about pay to play. In the past the legislature had proposed bills to counter corruption but currently to date no law has been passed to fight pay to play but I still proposed the following questions: Has the bidding companies agreed to publically disclose all of their political contributions from the last few years?

Has the bidding companies agreed to stop making any political contributions to lawmakers or political parties that may direct or indirect influence over the privatization process?

Local 195 was significantly supported at Kean University Board of Trustees meeting. Those in attendance were: Assemblyman Thomas Giblin, New Jersey AFL-CIO Secretary-Treasurer Laurel Brennan, Union County Central Labor Council President Jim McManus, President of Kean



Federation of Teachers James Castiglione, all the union officers and chapter presidents, retirees, student groups, AFT and CWA. Sadly, the Board of Trustees voted to move forward and privatize our membership.

On March 18, 2015 thru March 20, 2015, Local 195 met with individual members and Kean University management of Human Resources to go over and address the Declaration Forms for the layoff process and procedure. The final interviews are scheduled on April 6-8. Sadly, the separation date of employment for our members at Kean University is set for April 30, 2015.

Local 195, IFPTE has not given up fighting this battle. You may have seen flyers posted all over the campus or even on some windshields explaining that the company taking over called GCA Services which is a nationwide custodial services company based in Cleveland, Ohio which was then purchased by the Blackstone Group private equity firm has had numerous problems in its cleaning contracts. We, Local 195 will continue to battle and lobby against this privatization.
