IFPTE Victories During the Mid-term Elections

This November produced mixed results for unions and working families. However, IFPTE was able to support proven proworker candidates who prevailed at the ballot box, enabling them to continue the fight for our members. Some of these victories included candidates who will directly impact the work and livelihoods of Local 195 members.

In New Jersey, IFPTE endorsed New Jersey Representative Andy Kim and ran a mobilization program encouraging our members to support his reelection. Rep. Kim was targeted by anti-union special interests, as he was in the last election, because of what they perceived as a receptive voting population in his district. However, his constituents, which include hundreds of our members, clearly based their vote on Rep. Kim's record and not partisan political attacks. In New Jersey IFPTE also endorsed Representatives Don Norcross, Chris Smith, Bonnie Watson Coleman and Donald Payne, Jr, all who won their races.

In Pennsylvania, where many members from Local 195 and other IFPTE affiliates live, we were able to help several prounion candidates win on election day. This included targeted endorsements and contributions from IFPTE's Political Action Committee, as well as participating in grassroots voter outreach efforts. These labor-to-neighbor programs made all the difference for a number of candidates, including Governor-elect Josh Shapiro, Senator-elected John Fetterman, Representative Brian Fitzpatrick, and many running for city or county offices.

When it convenes its new session in January, the United States House of Representatives will be under new management. While many leaders who will likely control the House agenda are avowed opponents of unions and working families, IFPTE will continue its practice of working to build bipartisan support for our legislative agenda. By putting policy over party in the past, we have been able to effectively represent IFPTE members in Congress, and we believe this more thoughtful approach remains in our best interest.

Local 195 Wins Significant Improvements in Health Benefits Negotiations

Working with a coalition of unions throughout New Jersey, Local 195 was able to roll back some of the more draconian proposed changes in the state's health benefits plan. Earlier this year, the board of the State Health Benefits Program (SHBP) announced a plan to significantly shift healthcare costs to participants. These changes would have affected workers covered by the SHBP at the state, county and municipal level.

Local 195 and other unions with affected members began the fight against this anti-worker initiative immediately. Lobbying in the legislature and rallying in the streets, a united New Jersey labor movement was able to effectively push back against some of the worst aspects of this proposed plan.

However, the final policy still represents a move in the wrong direction. Local 195 will continue the fight against such anti-worker cost shifting measures and support our allies in elected office, both Democratic and Republican, who agree with us that this backroom deal by the SHBP board is wrong for New Jersey's civil servants and taxpayers.
